COLLEGES - Starting of a Private Degree college for Women, at Visakhapatnam by Sri Venkateswari Vidya Peeth, Visakhapatnam, during 1980-81 - Orders - Issued.

ORDER

Government permit the Management of Sri Venkateswara Vidya Peeth, Visakhapatnam to start a Private Degree College for Women, Visakhapatnam temporarily for ~~and~~ one year during the year 1980-81.

2. The permission accorded is subject to the following conditions:

(R) *Govt Corp Fund*

- a) The management should run the college without any Government grant either now or at any time in future.
- b) The management should deposit an amount of Rs. 2.00 lakhs (Rupees two lakhs only) in the joint account of the Chairman of the college Committee and the Director of Higher Education and it should not be operated for the normal functioning of the college. This amount is in addition to the Corpus Fund to be deposited as prescribed by the concerned University.
- c) The management should fulfil all the conditions stipulated by the University in regard to accommodation equipment staff, library and play ground etc., immediately. The management should not make admissions of recruit staff unless the university grants temporary affiliation.
- d) The management should collect tuition fee, special fee and Misc. fee at the rates not exceeding the limits prescribed by the Government or the Director of Higher Education from time to time. Any excess fee collected beyond the limits prescribed will be treated as income to Government.
- e) The management should allow fee concessions etc., to Scheduled Castes, Scheduled Tribes and Backward Classes as per the rules in force and the amount covered by such concessions will be reimbursed by the Government subject to the availability of funds in the budget in this regard and according to the rules prescribed by the Government from time to time.
- f) The management should follow the rules issued by Government from time to time in regard to reservations for Scheduled Castes, Scheduled Tribes and Backward Classes in respect of admission and also appointment of staff as per the staff pattern prescribed by Government and pay to staff the salaries and allowances as prescribed by Government. If the rule of reservation is not followed in respect of appointment of staff, the appointments so made are liable to be set aside/ disapproved. Besides, the management is liable to be suspended/ superceded and alternative arrangements will be made and also the college will be disaffiliated temporarily or permanently. The Principal should make admissions following the rules of time and he will be held responsible for violation of any rules and the management shall not interfere in this regard;
